B) Errors & Omissions:

C) Third Party Liability:

To pay claims which Insured becomes legally obligated to pay for accidental death, bodily injury, or illness of any third party, and physical loss or damage to third party's property not in Insured's physical care & custody in the conduct of Insured Service.

D) Customs Liability:

To cover claims for fines, penalties and confiscation of property imposed by any covered authority for negligent and unintentional breach of import or export regulations. The fines and penalties are limited to ADDITIONAL customs duty, sales tax and/or other monetary charges that would not have been due if Insured had not committed such negligent/ unintentional breach.
